A LETTER FROM EVP JUAN DE PABLO



As the world began to reopen after pandemic-related restrictions, the University of Chicago adapted quickly to take advantage of new and renewed opportunities. From the accelerated growth of international partnerships to faculty, staff, students, and other University members alike pursuing activities abroad, I have witnessed the ambition and eagerness of the University community to reengage globally amidst constantly evolving circumstances. Through it all, the UChicago Global team and the UChicago Centers abroad have worked tirelessly to redefine the breadth and depth of all that is internationally possible. I am proud to reflect on the work of this group and the rewarding year that we have had together.

Field-defining research at the frontiers of knowledge requires collaboration and partnership at scale, and the natural intersection of global engagement and science strategy is at the heart of the University of Chicago's mission. This past year saw concerted efforts to both nurture new connections and strengthen existing bonds. Our global operations have additionally expanded through the unique positioning of the UChicago Trust in India and careful work to ensure compliance with local regulations, which have allowed our faculty to conduct ground-breaking, on-the-ground research in India. Finally, we made critical strides to envision institutional engagement with Latin America and Africa.

The work of UChicago Global and the Centers is essential, manifold, and ever-expanding. This report features key accomplishments that highlight our growing impact and capacity for support in the University's pursuit of global excellence. I am pleased to reaffirm my commitment to the innovative and ambitious nature of the University of Chicago's international engagement in the year ahead.

UChicago Global drives strategic international initiatives for the University and supports institution-wide special projects in response to world events and in coordination with University leadership and stakeholders across campus.

SELECTED HIGHLIGHTS

Provost's Global Faculty Awards - Africa

Following an initiative in which UChicago Global conducted a survey of existing faculty initiatives and barriers to engagement in sub-Saharan Africa, UChicago Global will debut a new Provost's Global Faculty Awards (PGFA) funding stream for faculty research projects with a collaborative element in Africa in 2022-23. This funding mechanism will be implemented alongside the other seed funding streams managed by our office for Beijing, Delhi, Hong Kong, and Latin America.

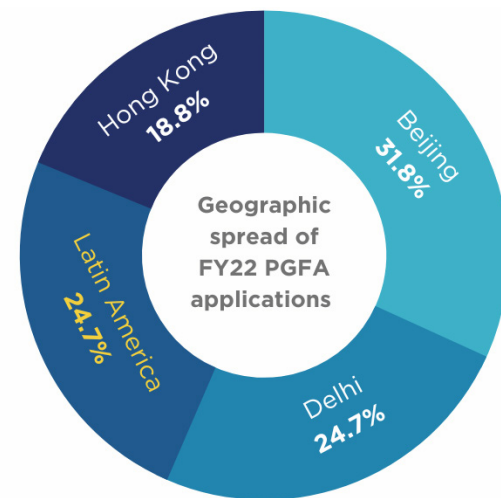
This development joins a growing list of cross-campus initiatives supporting institutional interest in engaging with Africa, including the newly launched **Kiphart Center for Global Health and Social Development** and the **Development Economics Center** at the Becker Friedman Institute. Across the University, hubs of academic engagement with Africa are well-established around public health, infectious diseases, development economics, and health provision, while other fields face logistical barriers that require a broader institutional response. Over the coming year, UChicago Global will continue to seek out ways to deepen our engagement while learning from individual faculty.

Latin America and Caribbean Faculty Steering Committee

In 2021-22, UChicago Global drove the formalization of the Latin America and Caribbean Faculty Steering Committee with extended terms, formal recognition of service, and a dedicated committee chair in order to better represent the strong cross-campus presence of individual faculty research and institutional partnerships in the region.

UChicago established the informal Latin America Faculty Working Group in 2017-18 to review applications and administer funds for the Latin America stream of the Provost's Global Faculty Awards (PGFA). Since that time, application numbers to PGFA-Latin America have been comparable in volume to other regions and have engaged faculty across all schools and divisions. The newly formalized committee will serve as a resource for these efforts and advise on region-specific topics and programming for the University, in addition to continuing to review PGFA-Latin America proposals each year. **Prof. Callum Ross** will serve as committee chair for the 2022-23 academic year.

Demand for funding in Latin America is comparable to demand for funding in Beijing, Delhi, and Hong Kong.

UCHICAGO TRUST IN INDIA

Established in 2008, the UChicago Trust in India is a non-profit charitable organization that broadly supports the University's education and research projects in India. The Trust gained approval to receive foreign contributions in 2019 through India's Foreign Contribution Regulation Act (FCRA), making the University of Chicago one of few academic institutions from the United States with this clearance.

SELECTED HIGHLIGHTS

Support to EPIC India

Since 2014, the Center in Delhi has been home to the **Energy Policy Institute at the University of Chicago's EPIC-India initiative**, which conducts foundational research, policy engagement, and public outreach to drive change around issues of energy and the environment in South Asia.

- EPIC-India is currently working to establish a local project management unit in the Government of Delhi with support from the Children's Investment Fund Foundation. This unit will provide support, management, and oversight on existing collaborations focused on reducing pollution in the state while initiating the development of new projects and strengthening operational frameworks.
- EPIC-India launched an initiative to design and implement emissions trading markets in India with the Ministry of Environment, Forest, and Climate Change, the Central Pollution Control Board, and the Gujarat Pollution Control Board.
- In May 2022, EPIC hosted the third Legislators Engagement Program for Indian Parliamentarians, which brought a delegation of nine Indian MPs to Chicago for a five-day visit to meet with UChicago experts on climate policy, carbon markets, air pollution, water quality, and related topics.

Receipt of First USAID Grant

This year, the Trust received its first US federal subaward, a grant from USAID for the **EPIC-India** project "Enabling a Clean Environment with Economic Growth." To receive the federal grant to the Trust, UChicago Global in partnership with the Trust conducted careful due diligence and managed an external advisory review of policies and processes due to USAID's extensive compliance obligations. Following this pilot, further financial policies, procedures, internal controls, and training protocols were established, codified, and communicated to the Trust and EPIC-India's operational, financial, and programmatic teams to promote continued compliance.

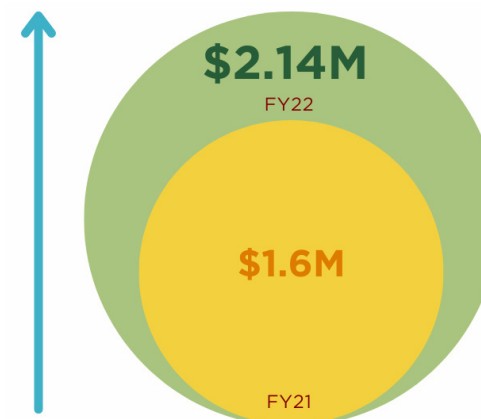
This grant allows EPIC-India to expand upon their projects and highlights the growing capacity of the Trust to navigate complex legal processes and ensure compliance. The success of this first instance of the Trust receiving US federal funding opens new pathways for institutional research and activity within India and positions UChicago as a leader in regional academic engagement.

Support to International Innovation Corps

The Center in Delhi is home to the **International Innovation Corps (IIC)**, a social impact fellowship program which places teams of diverse young professionals within the Indian government and leading social enterprises to work on multifaceted development projects. IIC is a joint initiative of the **Harris School of Public Policy** and the **Law School** at the University of Chicago.

- IIC is currently spearheading the development and enhancement of the Ayushman Bharat Digital Health Mission, which would create unique identifiers for citizens and verified healthcare professionals as well as a web application for exchanging healthcare information and managing patient consent.
- The Uttar Pradesh Technical State Unit IIC team is supporting the state of Uttar Pradesh's efforts to strengthen its digital health architecture in line with the efforts described above.
- The IIC team housed with Unified Health Interface (UHI) led the functional design for the application and redefined the development roadmap for the product.

Funds received and managed by the Trust in India have increased by more than 33% over the past year.

By pursuing and nurturing key institutional relationships in each region, we surface new opportunities for the University and its faculty, staff, and students.

SELECTED HIGHLIGHTS

Taiwan-UChicago Graduate Fellowship

As a result of a courtesy meeting with the new director general of the Taipei Economic and Cultural Office (TECO) in Chicago, in January 2022 UChicago signed a three-year agreement with the Taiwanese Ministry of Education to establish the Taiwan-UChicago Graduate Fellowship Program. The Ministry of Education committed to partially fund up to five incoming Taiwanese PhD students for their first four years of study in the **Divisions of the Biological Sciences, Humanities, Physical Sciences, and Social Sciences**; the **Pritzker School of Molecular Engineering**; or the **Divinity School**. The first cohort of fellowship recipients will begin their studies in the 2023-2024 academic year.

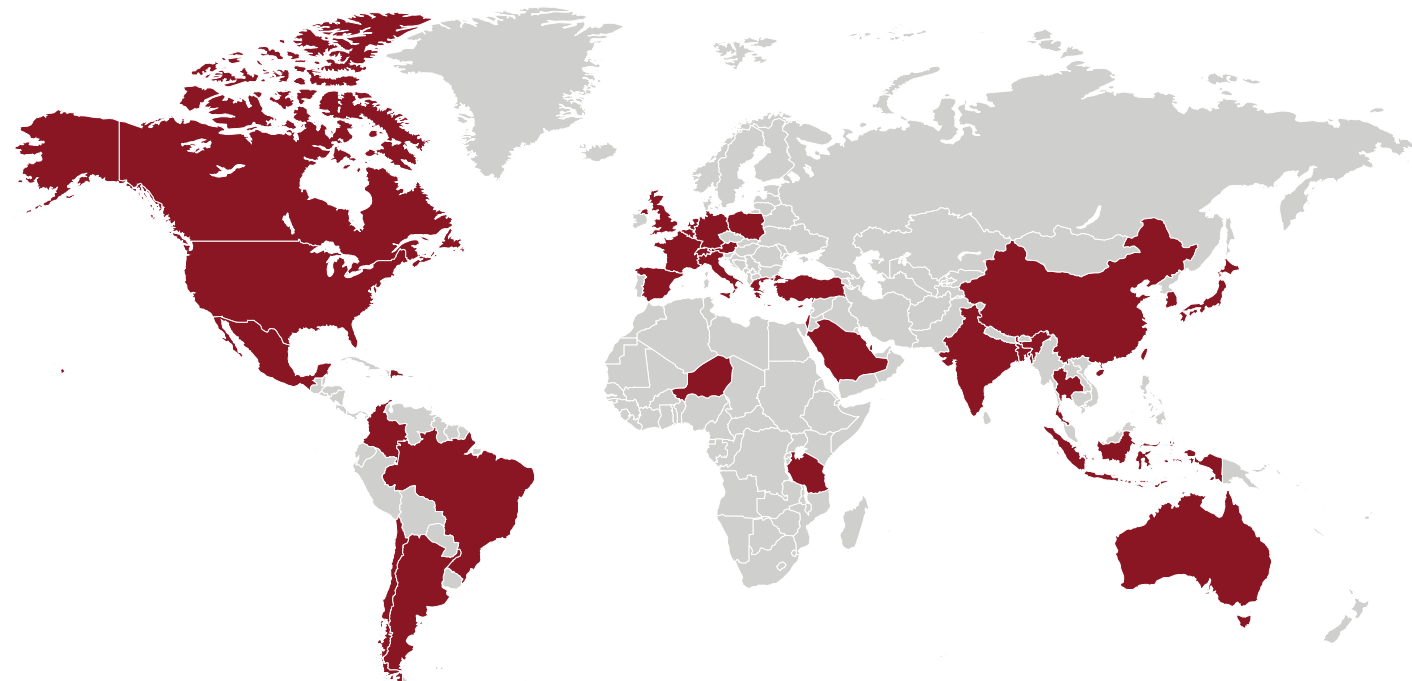
In addition to arranging the initial introduction between Director General Johnson Sen Chiang and EVP Juan de Pablo, we worked closely with TECO's Education Division, **UChicagoGRAD**, and the Deans of Students from relevant academic units to draft the agreement structure and clarify internal responsibilities. Global also hosted a virtual MOU signing ceremony to commemorate the partnership.

Consulate General of Israel to the Midwest

Over the past year, UChicago Global drove engagement with the Israeli Consulate along multiple lines:

- Connected the former Israeli Ambassador to the United Kingdom, Daniel Taub, to the **Pearson Institute for the Study and Resolution of Global Conflicts** for their Pearson Distinguished Speaker Series;
- Facilitated meetings between the Israeli Consul for Public Diplomacy Daniel Aschheim and leadership at the **Booth School of Business**, the **Harris School of Public Policy**, and the **Polsky Center for Entrepreneurship and Innovation** to discuss ideas for collaboration;
- Cross-promoted opportunities including the Young Diplomat Fellowship, Duality Accelerator, and internships at the Israeli Consulate; and
- Members of the UChicago Global team represented the University at several events hosted by the Israeli Consulate.

Active Formal Agreements in FY22



In 2021-22, UChicago Global supported 147 active institutional agreements in 31 global locations, serving 48 academic units across the University of Chicago.

Weizmann Institute of Science Funding

In 2021, the University of Chicago launched a new partnership with the Weizmann Institute of Science (WIS) in Israel to jointly support two new grant opportunities in quantum information sciences and the intersection of artificial intelligence and materials sciences or health and biology. The grants will fund up to \$500,000 for collaborative, 2-year projects to foster collaboration between the two institutions in these particular research areas. Funded projects aim to further knowledge of the quantum information sciences, better understand how artificial intelligence can improve our understanding of the rules of life from the molecular scale to multicellular organisms and ecosystems, and how artificial intelligence can be leveraged to predict properties and guide the design and synthesis of new materials.

National Autonomous University of Mexico

The University has strengthened its relationship over the past year with the National Autonomous University of Mexico (UNAM), a key partner in Latin America. Our renewed engagement with the UNAM Chicago office sparked several programmatic exchanges ranging from events to pathway programs to an interview with EVP Juan de Pablo on UNAM Chicago's Café Espresso YouTube series.

Throughout the year, UChicago Global connected UNAM with potential speakers for a variety of event series and facilitated visits to campus for several groups of UNAM students interested in exploring the University's graduate programs, also connecting them with **UChicagoGRAD** for information sessions and follow-up.

Dual PhD Programs with French Institutions

Since 2017, the University of Chicago has facilitated dual PhD degree programs with French institutions, through which PhD studies are simultaneously supervised by a UChicago faculty member and a counterpart at a degree-granting institution in France. The program allows students to access academic resources available at both institutions and the student earns two PhD degrees upon graduation. There have been 6 "cotutelle" students at the University since 2017, with 2 more joining in the coming months.

While the program offers many advantages, it also presents administrative complications, including negotiating student fee payment structures, insurance requirements, and coursework and dissertation requirements between two institutions. To streamline and standardize the process, UChicago Global worked with the **France Chicago Center**, **UChicagoGRAD**, and the **Office of Legal Counsel** to offer increased support for drafting, revision, and implementation of these agreements, paving the way for more joint enrollments and collaborations with French institutions in the future.

Engagement with the French Embassy

Throughout the year, UChicago Global worked with the Embassy of France and representatives of the French Centre National de la Recherche Scientifique (CNRS) to amplify our existing joint funding initiative (see p. 24) and develop plans for closer collaboration between our institutions.

To attract applicants and further encourage collaborative research between faculty at the University and partners in France, UChicago Global worked with the Embassy of France to secure \$20K in support of the **International Institute of Research in Paris'** Faculty Grants program. As a result of this funding, four projects were selected for implementation in the humanities and social sciences.

In October 2021, the French Embassy's Attaché for Higher Education and the new Consul General of the French Consulate in Chicago visited campus to discuss opportunities for deeper collaboration.

Chicago Consular Corps

UChicago Global has a long history of collaboration with the Chicago Consular Corps (CCC), a cohort of Consulates and Honorary Consulates based in the Midwest from over 80 countries. Members of the CCC provide key points of connection to their countries' respective governments and major institutions. UChicago Global manages consular relations for the University of Chicago.

Each year, UChicago Global partners with a unit to showcase a new aspect of the University at the Chicago Consular Corps Reception. The 2022 reception was hosted in partnership with **UChicago Arts** and saw first-time participation from Estonia, Hungary, Ireland, Lithuania, Serbia, and Ukraine.

Also in 2021-22, we launched the Chicago Consular Corps Global Research Awards for research on global policy challenges of diplomatic significance conducted by students enrolled in the **Center for International Relations (CIR)** Master's Program. Two students were awarded this year: Michael Bushnell (*Global Capital Markets and Cryptocurrency: Exploring the International Political Economy of Blockchain Ecosystems and Metaverse Development*) and Min Byung Chae (*Geopolitics vs. Public Health: Determinants of U.S. Overseas COVID-19 Vaccine Donations*). The two awardees had the opportunity to present their research to the CCC Executive Committee.

SELECTED HIGHLIGHTS

US-China Forum 2021: Addressing Inequality and Promoting Social Welfare

The annual US-China Forum, supported by the China-United States Exchange Foundation (CUSEF), convenes leading scholars to explore issues of importance to both countries and, by extension, the world. Over the course of three days in November 2021, UChicago Global held the sixth iteration of the Forum titled "Addressing Inequality and Promoting Social Welfare" in partnership with the **Crown Family School of Social Work, Policy, and Practice** at the David Rubenstein Forum and on Zoom. Speakers explored similarities and differences in how social policy and social service provision are leveraged to address social problems in the United States and China. The Forum convened a series of panel discussions on the public and private actors of social welfare provision in both nations; approaches to addressing health, mental health, and disability needs and supports; issues facing children and youth; and policy and practice responses to inequality between the two geographies.

Visit from the Czech Senate

In June 2022, UChicago Global hosted a delegation from the Senate of the Czech Republic. The program included a ceremony at the T.G. Masaryk Monument with the local Czech community and University members, meetings with University leadership to discuss opportunities for engagement, and the opening of the Jan Amos Comenius exhibition celebrating the Czech philosopher.

The **UChicago Library** currently houses the Archives of Czechs and Slovaks Abroad and UChicago has acted as a key facilitator for two past Czech presidents in helping to cement their relationships with the Czech and Slovak diaspora in the United States.

Latin American Presidents Event

Spurred by a meeting between EVP Juan de Pablo and former president of the Dominican Republic Leonel Fernandez, UChicago Global collaborated with the **Institute of Politics** to organize a moderated discussion with the former presidents of Costa Rica, Chile, Mexico, and the Dominican Republic in April 2022. The event explored the intersection of democracy and economic development in Latin America, informed by the former presidents' unique professional and personal experiences.

Exploratory Workshops on Quantum Science, Engineering, and Innovation

In April and May 2022, the **Pritzker School of Molecular Engineering, Chicago Quantum Exchange**, and the Office of Science, Innovation, National Laboratories, and Global Initiatives hosted back-to-back workshops on quantum science, engineering, data science, artificial intelligence, and innovation at the **Center in Paris** and **Booth London** campus. The events convened key local players in industry and academia to discuss potential collaborations and new developments in the fields.

World Health Day Media Event

To commemorate World Health Day on April 7th, 2022, the Center in Delhi hosted a virtual Q&A session on universal health coverage featuring faculty conducting related research in India. Professors **Nishant Agrawal, Osman Ahmed, Seeba Anam, Mohan Gundeti, Aniruddha Hazra, and Anup Malani** offered unique insights from their research on universal health coverage in India through the lenses of mental health, preventive and promotive healthcare, innovation and technology in healthcare delivery, improving medical education, and health financing. The session emphasized the need for multidisciplinary public health action and increased investment in human capital and infrastructure in India. The Q&A session garnered significant media coverage in India including the attendance of five media outlets and twelve published articles.

Exploring Collaborations with the Korea Foundation

In June 2022, UChicago Global hosted a delegation from the Korea Foundation, a charitable organization created to promote a better understanding of Korea and strengthen friendships in the international community. The Foundation funds a professorship in Korean Studies in the **Department of East Asian Languages and Civilizations**. Foundation President Guen Lee, EVP Juan de Pablo, and Senior Advisor to the Provost **Young-Kee Kim** discussed the possibility of involvement in a potential quantum research institute and increased collaboration in quantum sciences.



GLOBAL LOCATIONS

The University of Chicago has a variety of global locations, some serving the UChicago community generally and others supporting individual academic units.

The Centers in Beijing and Delhi and the Yuen Campus in Hong Kong meet the needs of faculty, students, and staff, engage local communities, and build relationships with key regional partners.

UChicago Global also coordinates with the University's global locations in Paris, London, Luxor, and Dhaka.

The University of Chicago Center in Beijing provides a physical presence to enhance and strengthen the University's traditionally strong ties to Chinese thought and culture, building upon more than a century of collaboration between scholars from Chicago and China.

FROM THE EXECUTIVE DIRECTOR

Since the onset of the COVID pandemic in early 2020, the Center in Beijing has taken the limitations of the moment and used them to build out new resources and areas of focus to continue supporting the University's goals in mainland China. We have seen particular success in public outreach and community engagement, as the lack of international travel turned our focus to the local community in Beijing. While much of 2020 and 2021 was focused on providing a UChicago home for Chinese students who were unable to travel to the US, this academic year gave us the opportunity to focus on communications to build our local profile and maintain the strong thread of connection between UChicago and China.

Despite frequent disruptions to our operations due to China's "dynamic zeroing" policy, the Center remained open for business and visitors as much as possible. We established two permanent public lecture series and increased efforts to source content for our social media accounts. We have also worked to maintain existing partner relationships and cultivate new ones.

As the impact of the pandemic wanes and China gradually loosens its travel restrictions, we expect increased mobility and academic activities at the Center over the coming year. We look forward to welcoming the University of Chicago community back to the Center in Beijing.

Strengthening Social Media Presence

Over the past year, the Center in Beijing has built up its public WeChat account (the primary social media platform in China) to become the most active account with the greatest amount of engagement among our US-based peers. Center staff developed a pipeline for content from the University that is of interest to the Chinese community, including news, events, announcements, faculty profiles, research discoveries, and more, with an emphasis on timely topics and application to people's daily lives. Each article averages around 1000 unique views.

In addition, the Center in Beijing also manages WeChat accounts for other units at the University, since all public accounts must have verifiable Chinese addresses and business licenses. Accounts for College Admissions and the Yuen Campus in Hong Kong have been successful in allowing these units to engage the mainland Chinese public, an audience that would otherwise be difficult to reach.

FROM THE EXECUTIVE DIRECTOR

In 2021-22, the Center in Delhi carefully nurtured the learnings of the previous year and brought them to bear on new opportunities born out of the constraints of the pandemic. While COVID limited our ability to conduct in-person programs, it also enabled us to reach out to a far wider audience from around the world. This year, as in-person activities resumed in India, we focused on hybrid events to leverage the benefits of both intensive in-person discussions and enabling a broader group of participants to join online. This also had a tremendous organizational impact. The Center in Delhi's staff teams mastered the art of conceptualizing and planning events with the goal of making them relevant and effective for both online and in-person participants.

Learnings and experiences from COVID-19 have also enabled the Center and its affiliated faculty to explore new thematic areas of work—including, for example, the mental health impacts of COVID on Indian and Bangladeshi youth, a multicentric study on COVID migrants in India, and the pandemic's impact on household-level health expenditure. While UChicago faculty were largely unable to personally visit their research and implementation sites in India, Center teams were able to provide support by exploring local partnerships with alumni and local organizations in the relevant areas and re-energizing some older associations.

We are envisioning 2022-23 to follow the same trend of surfacing new opportunities stemming from the challenges of COVID-19. While India continues to grapple with immediate issues like lack of adequate health infrastructure and an overall decline in growth and economic development, longer-term issues such as

health and education may have far-reaching consequences and become potential threats in future. The Center in Delhi intends to respond to this situation by engaging the University of Chicago's scholarship in the areas of health, education and livelihood, connecting scholars with the local ecosystem, and attempting to bring about sustainable changes through collaboration with government and civil society.

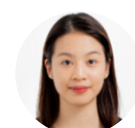

FROM THE EXECUTIVE DIRECTOR

In the 2021-2022 academic year, the Yuen Campus team in Hong Kong focused on connecting the UChicago and Hong Kong communities by offering diversified in-person, hybrid, and online programs and pursuing innovative ways to build and maintain important relationships.

We organized 36 events in 2021-22, including virtual and hybrid webinars and academic workshops, in-person alumni celebrations, and a music concert and engaging 24 UChicago faculty throughout the year. In addition, as the COVID-19 situation improved, the Heritage Interpretation Centre and Japanese

War Propaganda exhibition were reopened to visitors from the community. We also began a foray into new areas of digital communications, working with 16 UChicago faculty members to develop our new podcast series *The Course*. We also continued our support for **Chicago Booth's** activities in the region, including the EMBA-Asia program.

2021-22 has been a fruitful year with breakthroughs and growth despite the challenging conditions. We look forward to an exciting year to come as travel resumes and our communities can reconnect in person once again.

Collaboration with the Booth School of Business

As the home of the **Chicago Booth** EMBA-Asia program, the Yuen Campus is home to 15 dedicated Booth staff and has supported Booth initiatives in many ways over the past year, including student support, alumni engagement, student recruitment, event support and promotion, and more.

This year, the Yuen Campus team began an integrated initiative to track and share information on event attendees with the Chicago Booth admissions and alumni relations teams, sharing more than 3,400 contacts for outreach and follow-up.

While travel to and from Hong Kong remains heavily restricted, EMBA-Asia students living in Hong Kong have used the Yuen Campus throughout the year for group remote instruction and self-study. The Yuen Campus team also supports event marketing and staffing for many Chicago Booth events and activities, including promotion and on-site support for Worldwide Booth Night 2021.

Jockey Club Musicus Heritage Alive Concert

The Jockey Club Musicus Heritage Alive Concert was hosted at the Yuen Campus Hong Kong on Dec. 4 and 5, 2021. The event was a collaboration between the Yuen Campus and the Musicus Society under the Jockey Club Musicus Heritage Alive program, which transforms heritage locations across Hong Kong into ad hoc concert stages with thematic programs and new works inspired by the history of the venues.

The performances featured Hong Kong artists including award-winning pianist Rachel Cheung and violinists Brian Choi and Fan Hiu-sing, as well as many instrumentalists from Canada, the Netherlands, and Israel.

Over 200 music enthusiasts, UChicago alumni, and friends participated in this unique journey in music and culture, followed by a guided tour of the heritage campus.

SEED FUNDING

We offer seed funding for faculty-led collaborative international research and academic activities in key regions.

FUNDING MECHANISMS

UChicago Global offers opportunities for flexible seed funding for faculty and other academic appointees with the goal of advancing international partnerships through joint research, public and academic events, training initiatives, research residencies, and experiential learning in key regions around the world.

FUNDING STREAMS

Provost's Global Faculty Awards

The Provost's Global Faculty Awards (PGFA) provide annual awards of up to USD \$30,000 to support international faculty activities with a strong collaborative element in mainland China, Hong Kong and East Asia, India and South Asia, and Latin America. The grant mechanism is open to all UChicago faculty and other academic appointees. Projects showcase UChicago scholarship incorporating meaningful participation and expertise from both the University and a partner in the target region.

Yuen Research Grants

The Yuen Research Grants provide awards of up to USD \$100,000 to support faculty research in Hong Kong and the Greater Bay Area of mainland China for up to two years, with new projects funded quarterly. This program, funded by Francis Yuen (AB'75) and Rose Yuen, aims to highlight and strengthen the rich tradition of academic collaboration between the University of Chicago and partners in the target region.

CNRS Research Collaboration Program

The program supports up to 5 new research collaborations annually between UChicago and CNRS with awards up to USD \$15,000 over three years. The framework encourages and supports transatlantic exchange of PhD students, whose efforts underpin the collaboration of one UChicago faculty member and one researcher affiliated with CNRS.

Weizmann Institute of Science Research Collaboration Program

UChicago's partnership with the Weizmann Institute of Science (WIS) in Israel supports two new grant opportunities in Quantum Information Sciences and the intersection of artificial intelligence and materials sciences or health & biology, the latter in cooperation with the **Toyota Technological Institute at Chicago**. The grants fund up to USD \$500,000 for collaborative, 2-year projects to foster collaboration between the two institutions in these research areas.

Community-Based Development of Trans-Affirmative Health Education in India

Provost's Global Faculty Awards - Delhi
PI: Aniruddha Hazra (Medicine)

Transgender and non-gender binary (TGNB) communities in India have been historically discriminated against, stigmatized, and oppressed, issues complicated by intersectionality within minority caste and ethnic populations. To take steps toward systemic, participatory, and inclusive trans-affirmative medical curricula in India, **Prof. Aniruddha Hazra** held regional workshops in Delhi, Bhopal, and Manipal to train trans-affirmative health professionals. A national conference at the Center in Delhi in May 2022 was also held to create a set of core competencies on trans-affirmative healthcare in India and build consensus. Going forward, the team will continue to develop these core competencies with stakeholder input and will also expand the Queer Ambassadors program, which provides resources and trainings for higher education institutions to facilitate LGBTQIA+ inclusive environments on their campuses.

PGFA-Delhi funding supported travel and accommodations for UChicago and India-based participants, conference costs, and personnel and equipment costs for local teams.

STEM-Out Mexico

Provost's Global Faculty Awards - Latin America
PIs: Sonia Hernandez (Surgery) and Oscar Pineda Catalan (BSD Collegiate Division)

Mexico produces immense human talent in STEM fields, but students regularly face barriers to access and resources that inhibit them from building the skills and experience needed to pursue graduate studies. To alleviate these obstacles, **Prof. Sonia Hernandez** and **Senior Lecturer Oscar Pineda-Catalan** have developed STEM-Out Mexico, a program creating STEM research and training opportunities for Mexican high school and undergraduate students. Research-based workshops are developed and taught by UChicago graduate students and postdoctoral researchers in partnership with Mexican counterparts, who receive training in curriculum development, mentorship, and STEM communication. Now in its 4th year, STEM-Out has cemented crucial collaborations with Mexican institutions and has profoundly impacted participating students, trainees, and coordinators.

Funding and institutional support from the PGFA-Latin America has enabled the organizers to reimburse foreign collaborators, deliver experiment materials to students' homes for remote participation in workshops during COVID, and travel for the PIs to Chihuahua for an in-person visit and workshop at the Autonomous University of Chihuahua, an important partner in the STEM-Out program.

Peer Support Services for Persons with Severe Mental Illnesses in Guangzhou, China

Yuen Research Grants
PI: Zhiying Ma (Crown)

Since 2019, **Prof. Zhiying Ma** has worked with local partners in Guangzhou, China to develop and pilot a culturally-responsive peer support training, certification, and supervision program for persons with serious mental illnesses in Guangzhou, China. Funding and support through the Yuen Research Grant program allowed Prof. Ma to plan and implement a pilot program and analyze its results. Following the successful pilot and thanks to the University's demonstrated support of her efforts, Prof. Ma was awarded \$1.2M from the Cyrus Tang Foundation to fund the expansion of her program to a broader, more diverse area, demonstrate its feasibility and effectiveness, formulate training and supervision standards, and promote them among policy and service leaders. The project will strengthen mental health services in the Greater Bay Area while providing guidance for mental health policy and service reforms across China and in other developing countries.

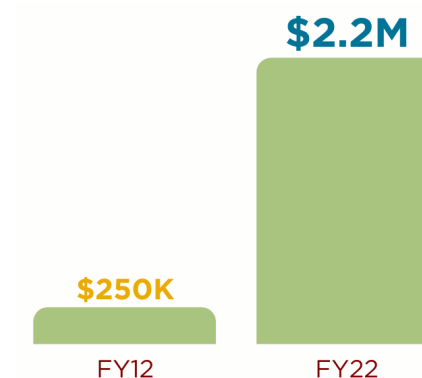
Was the United States Invented By a French Philosopher?

CNRS Research Collaboration Program
PI: Paul Cheney (History)

Prof. Paul Cheney, Prof. Céline Spector (CNRS), and PhD student Hugo Toudic (CNRS) explored the influence of the French philosopher Montesquieu on the ideology of the American Founding Fathers through the lens of the Federalist Papers. To this end, the Montesquieu Conference was held in June 2022 at Sorbonne University in France, gathering prominent historians, philosophers, and political scientists across the globe for a three-day investigation into the role of Montesquieu's legacy on the oldest constitution in existence today. A selection of papers arising from the conference will be published by Oxford's Voltaire Foundation.

The UChicago-CNRS grant enabled US-based researchers to attend the conference and will continue to support mobility related to Toudic's dissertation development.

Seed funding awarded by UChicago Global has grown nearly eightfold over the past decade.
